Waiver and Release of Liability/Informed Consent Agreement Regarding Voluntary Sports, Events, or Activity

We understand that sports by their very nature, pose inherent dangers of serious personal injury that no amount of care, caution, training, coaching, instruction, supervision, condition of the property or expertise can eliminate. These injuries could include, but are not limited to the following:

- Sprains/strains
- Disfigurement
- Cuts/abrasions
- Head Injuries
- Unconsciousness
- Loss of eyesight
- Paralysis
- Fractured bones and dental damage
- Communicable diseases
- Dehydration
- Back & neck injuries
- Death

ALL PARTICIPANTS IN THE SPORT(S) SHOULD UNDERSTAND THAT THE PARTICIPATION IS VOLUNTARY AND IS NOT REQUIRED BY THE SCHOOL DISTRICT

Based upon the foregoing, we (parent/guardian and participating student all hereafter referred to as "Releasors") hereby forever release, discharge, agree not to sue, and hold harmless the ACALANES UNION HIGH SCHOOL DISTRICT, its employees, Board of Trustees, Board of Directors, School Board Members, officers, agents, employees, representatives, coaches, instructors, volunteers, referees, sponsors and any other persons affiliated with above named sport, event or activity (all hereinafter referred to as "Releasees") from any and all liabilities, claims, demands, suits, actions, causes of action or losses of any kind or nature, past, present or future, direct or consequential, the undersigned may hereafter have for PERSONAL INJURY, DISABILITY, DISFIGUREMENT, PARALYSIS, HEAD INJURIES, AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY, INCLUDING DEATH, arising out of participation in the above named sports, events or activities, HOWEVER CAUSED, EVEN IF CAUSED, IN WHOLE OR IN PART BY THE ACTION, INACTION OR THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES or the CONDITION OF THE PROPERTY OR PREMISES BEING USED, TO THE FULLEST EXTENT OF THE LAW, and also including, but not limited to losses caused by hidden, latent or obvious defects in the facilities, property or equipment used.

Further, Releasors acknowledge and fully understand that there may be other associated risks with sports which are not known or not reasonably foreseeable at this time and this waiver expressly applies to these activities and injuries. We further recognize that we are voluntarily participating in sports, events or activities with full and complete knowledge of the risks associated with such participation, and hereby agree to accept any and all risks of personal injury and damage.
